

NCSS provides an adolescent system of care that blends Mental Health and Substance Abuse Services offering seamless, integrated treatment to the communities we serve. Along with individualized service plans, Adolescent Services provides the following interventions.

DRUG AND ALCOHOL TREATMENT SERVICES FOR YOUTH 12-18:

Includes comprehensive evaluation, referral and clinical substance abuse and behavioral health treatments for youth who are experiencing concerns with psychoactive substances. NCSS serves as the treatment provider for the Franklin County Juvenile Treatment Court and also has established relationships with some area high schools, embedding substance abuse clinicians within the school setting.

TRANSITIONAL CASE MANAGEMENT SERVICES FOR YOUTH 16-21:

Includes community-based supports from the JOBS (Jump on Board For Success) and Transitional Living Program to assist youth with successful transition to adulthood. Services range from support with finishing their education; career counseling; individual job placement; managing money; getting an apartment; advocacy and connection with area resources; problem solving, positive coping and social skills training.

GROUP-BASED SUPPORTS:

Includes opportunities with the Youth In Transition Program to participate in a diverse youth leadership team which plans and hosts events geared toward youth voice, developing leadership skills, and forging closer relationships between youth and their communities. Other group opportunities such as participation in curriculum related to healthy relationships and sexuality are held throughout the year.

Early Head Start and Head Start are national programs that provide services to families with children ages 0–5. Services include: education, health, nutrition, mental health, and social services that help families and children to grow and to do well in school and in life. Early Head Start and Head Start help parents to take the lead role in their child's learning and development, to be their child's first teacher, and to build positive family relationships. CVHS provides services for children with special needs, including those with severe disabilities, and helps families to access public community transportation services, such as bus vouchers and SSTA or PCC vans. Early Head Start serves pregnant women and families with children from birth to 3 years of age. Head Start serves families with children 3 to 5 years of age. Services are **FREE** for all eligible families, though some childcare fees may apply in childcare centers in which Head Start services are provided.

Champlain Valley Head Start offers a range of services to meet the needs of different families.

Full-day, full-year classrooms (EHS & HS): Children attend a classroom in a local childcare center five full days each week, year-round.

Part-day, school-year classrooms (Head Start Only): Children attend a preschool classroom four or five times each week (mornings or afternoons) from September through June.

Part-day, combination classrooms (Head Start Only): Children attend a preschool classroom each week (mornings or afternoons) from September through June, and receive one home visit per month with a Head Start teacher.

Home-based program (EHS & HS): Children and families receive one home visit per week with a Home Visitor and take part in playgroup activities twice per month. The Early Head Start program runs year-round. The Head Start program runs September through May.
